1. Supplier Information

2. Baseline Emissions Footprint

Baseline Year: December 2022 - November 2023

Calculation Methodology: Greenhouse Gas Protocol Corporate Standard (2015) using 2023 UK Government Conversion Factors. Assessment completed by Chamber Low Carbon (East Lancashire Chamber of Commerce).

3. Carbon Reduction Targets

We aim to reduce our total emissions by 50% by 2028 (from $8.86 \text{ tCO}_2\text{e}$ to $4.41 \text{ tCO}_2\text{e}$).

Target Pathway:

2023 - 8.86 tCO₂e

2025 - 6.65 tCO₂e

2028 - 4.41 tCO₂e

2040 - Net Zero



4. Carbon Reduction Initiatives

Operational Efficiency

- Replacement of all lighting with energy-efficient LED fittings and use of PIR/daylight sensors.
- Installation of low-flow sanitaryware.
- Restoration of blocked rooflight in warehousing to reduce lighting demand.

Energy & Buildings

- Review and replacement of AC/heating systems with low-carbon alternatives.
- In partnership with the landlord, commission three quotes for Solar PV and battery storage systems.
- Introduce internal sub-metering to track and optimise energy consumption.

Transport & Logistics

- Prioritisation of round-trip logistics to reduce fuel usage.
- Exploration of alternatives to diesel vans for contractors.
- Develop a monitoring system to capture delivery and installation emissions.

Procurement & Waste

- Implement a company-wide Sustainable Procurement Policy, assessing supplier sustainability credentials.
- Explore renewable electricity tariffs and green supply options.
- Introduce waste/resource audit procedures and recycling enhancement programmes.

Governance & Engagement

- Appoint an internal Environmental Champion to lead ongoing Net Zero strategy.
- Conduct annual carbon footprints, including all GHG categories.
- Engage supply chain partners in reducing Scope 3 emissions.

5. Declaration and Compliance

This Carbon Reduction Plan complies with:
